a. <u>Approval of Renewal Agreement Between Sachem Central School District and Aesop</u> <u>Frontline Placement Technologies, Inc.</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. LaCarrubba, and carried unanimously (8-0) to approve the renewal agreement between Sachem Central School District and Aesop Frontline Placement Technologies, Inc. for the purchase of a subscription for 24/7 access to Frontline's computer system, called "Aesop", for teachers requiring a substitute. The estimated annual fee is \$24,397.50 for the 2010/11 school year. This will be paid by General Fund. This contract has been reviewed and approved by the school district's attorney.

b. <u>Approval of Agreement Between Sachem Central School District and Fireworks by</u> <u>Grucci, Inc. – Sachem East</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. LaCarrubba, and carried unanimously (8-0) to approve the agreement between Sachem Central School District and Fireworks by Grucci, Inc. to provide a fireworks performance at Sachem High School East on October 22, 2010 at a cost of \$5,000. This is being

paid by Student Government funds. This agreement has been reviewed and approved by the school district's attorney.

c. <u>Approval of Renewal Agreement Between Sachem Central School District and Town of</u> <u>Brookhaven – Snow removal, Salt Sand, General Repairs</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. LaCarrubba, and carried unanimously (8-0) to authorize the President of the Board of Education, Robert Scavo, to execute the renewal of the agreement between the Sachem School District and the Town of Brookhaven for snow removal, salt sand, and general repairs as needed.

d. <u>Approval of Agreement Between Sachem Central School District and Music Theatre</u> <u>International (MTI)</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. LaCarrubba, and carried unanimously (8-0) to approve the production contract between Sachem Central School District and Music Theatre International (MTI) to provide materials, security fee and a royalty fee for the production of *The 25th Annual Putnam County Spelling Bee* at Sachem High School North. e. <u>Approval of Agreement Between Sachem Central School District and CDW Government</u> <u>LLC</u>

Dove, Ed.D. to provide high school special education teachers with training in co-teaching using the Sheltered Instruction Observation Protocol (SIOP) Model. At the time the roof was originally installed, the School District secured a 20-year warranty from the roofing manufacturer, Johns Manville. When the School District became aware that the roof was failing, it contacted Johns Manville to meet its obligations under the warranty. Manville has refused to honor its warranty on the roof. As a result, in order to insure the integrity of the building, the School District was required to proceed with the reroofing project. The upper roofs have been re-roofed at this time. The resolution on the Board's agenda tonight is to complete the re-roofing at the lower roofs, which are also failing. In light of Johns Manville's refusal to honor its warranty, the Board authorized its attorneys to commence litigation against Johns Manville and Aurora Contracting, the original contractor on the project. The Board has settled its claim against Aurora and will continue to prosecute its claim against Johns Manville.

Approval of Emergency Partial Roof Repair/Related Work - Sachem High School East
