VII.ACTION ITEMS

1. Adoption of 2017-18 Budget

7.1.1. Adoption of 2017-2018 Budget

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Ms. Slattery, and seconded by Mr. Scavo, and approved unanimously (9-0), to approve the following resolution to adopt the 2017-2018 budget of \$314,191,536 and said budget to be presented to the registered voters on May 16, 2017. This equates to a tax levy increase which is 3.47% above the prior year (2016-2017) tax levy:

RESOLVED, that the budget for the Sachem Central School District in the amount of \$314,191,536 shall be approved, a tax levied therefore upon the taxable property of said School

District. Adoption of this budget requires a tax levy increase of \$5,936,231 and, therefore, does not exceed the New York State tax levy limit including exemption, and must be approved by greater than 50% of the qualified voters present and voting.

If in the event the May 16, 2017 budget vote is defeated by the community, the Board of Education may opt for a re-vote on June 20, 2017. The same budget or a revised budget may be submitted for a re-vote. If there is no re-vote, the Board of Education must approve the contingency budget in the amount of \$308,255,305.”

7.1.2. Adoption of Smart Schools Investment Plan

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Ms. Slattery, and seconded by Ms. Ahearn, and approved unanimously (9-0), to approve the following:

WHEREAS, the Board of Education of the Sachem Central School District held a Public Hearing on April 19, 2017, and received public comment regarding the District’s proposed Smart Schools Bond Act Preliminary Investment Plan; and

WHEREAS, the Board of Education has reviewed the final Smart Schools Investment Plan (“SSIP”) and determined that approval of the final SSIP is in the best interest of the District.

BE IT RESOLVED, that the final Smart Schools Investment Plan is hereby approved; and

BE IT FURTHER RESOLVED, that the Board of Education hereby authorizes submission of the final SSIP to the New York State Education Department.

2. Mini Contracts Consent Agenda for Action Items 7.2.1 through 7.2.7.

7.2.1. Resolution to Approve the Eastern Suffolk BOCES 2017-18 Annual Administrative Budget

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to approve the Eastern Suffolk BOCES 2017-18 Administrative Budget.”

7.2.2. Approval of Agreement with St. Joseph School 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to approve the agreement between Sachem Central School District and St. Joseph School to provide lunch service to the students at St. Joseph School. St. Joseph School will pay the School District \$3.75 per individual meal provided and \$0.25 per individual milk provided daily. This agreement shall be in effect for the period September 12, 2016 through June 30, 2017. This agreement has been reviewed and approved by the school district’s attorney.”

7.2.3. Donation - Samoset Middle School PTA

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to accept with gratitude, donations from the Samoset Middle School PTA in the amount of \$28,135.11. These donations are for the BOCES Performing Arts Code A2111-30-4971.”

7.2.4. Donation - Cadette Girl Scout Troop 582

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to acknowledge, with gratitude, a donation from Cadette Girl Scout Troop 582 of their time and materials for improvement to the atrium at Samoset Middle School. The approximate value of this donation is \$1,500.00.”

7.2.6. Amendment to the Agreement with Bayada Home Health Care 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to approve the amendment to the agreement between Sachem Central School District and Bayada Home Health Care to include the following paragraph:

Service Provider shall provide the District with an R.N. to accompany one student on a school-related overnight trip.

The payment schedule shall be amended to include a payment fee of \$500.00 per day for a personal R.N. All other terms and conditions remain the same. This amendment has been reviewed and approved by the school district’s attorney.”

7.2.7. Approval of Agreement with Spirit of Dance Awards

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Coggin, and seconded by Ms. Ahearn, and approved unanimously (9-0), to approve the agreement between Sachem Central School District and Spirit of Dance Awards to lease the auditorium at Sachem High School East on April 29, 2017 from 6:00 a.m. to 11:59 p.m. The tenant agrees to pay, without set off or demand, rent in the amount of \$11,000. This agreement has been reviewed and approved by the school district’s attorney.”
